Please join NAITA for a breakfast briefing on *Doing Business with the United Kingdom*, including perspectives on the impact of Brexit. The presentation will offer a brief introduction to UK Corporate Governance, Current Issues in the UK, Opportunities and Resources related to the UK, as well as a Cultural Perspective and Speaking (and Listening) British.

[Major General \(USA Ret.\) John Holly](#), Senior Defence Advisor for KPMG and Chairman of JH London Associates Limited, will present the briefing. JH London is a bespoke, high technology consultancy specializing in high-consequence, risk-sensitive operations. Additionally, MG Holly is the Deputy Chairman of eCommodities PLC, an eco-friendly, precious minerals mining company, and a Senior Advisor to Glasswall Solutions Ltd., an innovative cyber security company.

John Holly is an experienced senior industry executive and former soldier. During a distinguished career in the United States Army, he rose to the rank of Major General leading the development and initial deployment of the National Missile Defense System for the United States of America against Intercontinental Ballistic Missiles (ICBM). Additionally, he was the Program Executive Officer for the Army's Tactical Missiles. His final military assignment was the Deputy Director of the Missile Defense Agency.

Prior to establishing JH London, his recent industry experience included serving as the Chairman of the UK Atomic Weapons Establishment Management Limited (AWE ML), and Chief Operating Officer of Lockheed Martin UK. Prior to moving to London, he was the Vice President of Missile Defense Systems in Lockheed Martin's Space Systems Company and the Vice President for Huntsville Operations for Lockheed Martin Corporation. He also served as President and Managing Director of Analytical Services incorporated.
